THEY LEARN TO WORK INDEPENDENTLY AND AS A GROUP TO SOLVE PROBLEMS. ABOUT 350 KIDS GRADUATE FROM THE PROGRAM EVERY YEAR, EARNING THEIR OWN BIKE, HELMET, LIGHT AND LOCK. ST.
